## **NON-PROFESSIONAL MEMBERS' ENHANCED PUBLIC LIABILITY INSURANCE COVER FOR MEMBERS OF THE SCOTTISH GAMEKEEPERS ASSOCIATION**

Members of the Scottish Gamekeepers Association (SGA) are covered by a Public Liability Limit of Indemnity of £10,000,000 any one occurrence whilst taking part lawfully in any recognised Gamekeeping and/or Country Sports activity endorsed by the SGA\* including member to member liability; and including Non-Professional stalkers, ghillies, and gamekeepers whose names are held by the Scottish Gamekeepers' Association and have paid the appropriate premium whom derive an income of not greater than £5,000 per annum from such activities; and if not covered by any other insurance.

The Territorial Limits under the policy are The United Kingdom of Great Britain and Northern Ireland, The Channel Islands and The Isle of Man.

Cover is provided proportionately by the following: Royal & Sun Alliance Insurance Ltd, AIG Europe Ltd, Covea Insurance plc through Lycett, Browne-Swinburne and Douglass Ltd; Policy number OXY265/16; Policy period 28 November 2016 to 27 November 2017.
